The Granite Falls Town Council has called for a Special Meeting on Monday, February 15, 2021 at 6:00 p.m.

Due to COVID-19 (Coronavirus) the meeting will be broadcast electronically using Zoom software to allow for remote participation by Town staff, members of the media, citizens and members of the general public, and all other interested parties. To provide adequate social distancing, only the Mayor, Town Council, Town Clerk, Town Manager, Town Finance Officer, ZOOM Meeting Administrator, Town Attorney, Department Heads that are on the agenda, and one member of the public at a time will be permitted to enter the Town Council Chambers.

What does this mean for those looking to participate in the meeting?

**There are four ways the public can participate in the meeting:**

1. Join the meeting through Zoom on your computer or smartphone.

If you have not used Zoom before, you are encouraged to download the application from their website at Zoom.us and try it out prior to the meeting. There is no cost associated with the software or attending the meeting. If you are having trouble downloading the software, please call the Town Office before 12 p.m. on Monday, February 1 so we can assist you.

2. Join the meeting through audio only via telephone.
